Steven K. Vogel is the Il Han New Professor of Asian Studies and a Professor of Political Science at the University of California, Berkeley. He specializes in the political economy of the advanced industrialized nations, especially Japan. He is the author of *Japan Remodeled: How Government and Industry Are Reforming Japanese Capitalism* (Cornell, 2006) and co-editor (with Naazneen Barma) of *The Political Economy Reader: Markets as Institutions* (Routledge, 2008). His earlier book, *Freer Markets, More Rules: Regulatory Reform in Advanced Industrial Countries* (Cornell, 1996), won the Masayoshi Ohira Memorial Prize.
