FFJ was created within the École des hautes études en sciences sociales (School of Advanced Studies in the Social Sciences, EHESS), a unique and prestigious school within the research community and higher education in France. In 2020, EHESS and FFJ will be relocated to the Campus Condorcet, an international campus for the humanities and social sciences, one of the biggest in Europe. ## Promoting an open approach

In line with EHESS, the FFJ team favours an interdisciplinary approach (including economics, sociology, political science, urban planning, anthropology...) in its scientific research. FFJ is also proud to recognize the quality of students' and young researchers' writing through two awards: the Christian Polak/FFJ Prize for the Best Master's Thesis on Japan and the FFJ/SASE Award for the Best Paper on Asia.

## Building an international scientific community

### Visiting researchers

One of the core missions of FFJ is to welcome Japanese researchers, as well as other international researchers studying Japan, with a special commitment to diversifying profiles in terms of discipline, age, gender, and country of origin. Our fellowship programme, which covers several thematic fellowships funded by our partners, allows international researchers to be hosted in Paris for a long research stay, thus creating the opportunity for a close collaboration between the fellows, FFJ and its partners.

### Le Cercle de la FFJ

Through the years, we have developed a large international network of researchers, young and experienced alike, in the humanities and social sciences, as well as extra-academic experts. To highlight this network and foster cooperation between its members, in November 2019, we launched the Cercle de la FFJ, which will organize an annual meeting and publish a bi-annual journal to share their experience.

## Bringing together academic and extra-academic actors

### A specific approach

The underlying challenge of the Fondation France-Japon de l'EHESS' collaboration with companies and corporate foundations, and one of its main missions, is to connect the worlds of research and business. This dialogue is based on how the humanities and social sciences can contribute, through a theoretical framework providing the necessary perspective on studied phenomena, to understanding the major challenges we face and identifying how to address these challenges.

### Examples of collaboration

- A short-term study focused on a specific topic and discussed in a workshop with the partner
- A fellowship funded by the partner to welcome distinguished international scholars
- A multi-annual and multi-faceted research programme, including a series of meetings, publications and a public conference

For ten years, FFJ has been promoting collaboration between the academic and extra-academic sectors through the development of some forty partnerships, bringing together actors from universities and research institutions, local authorities, major companies, French and Japanese ministries and embassies, and private foundations.
